

AGRSS Logo License Agreement for Registered Companies

The attached logo(s) are the property of the Automotive Glass Replacement Safety Standards (AGRSS) Council, Inc. but may be used by AGRSS registered companies in good standing in accordance with the terms and conditions set forth below. Use of one or more of the logo(s) shall constitute consideration for, agreement to, and acceptance of the following terms and conditions of this license by the user:

1. The attached logo(s) are the sole and exclusive property of AGRSS. These logo(s) may be used only by AGRSS registered companies in good standing if and only if such use is made pursuant to the terms and conditions of this limited and revocable license. Any failure by a user to comply with the terms and conditions contained herein may result in the immediate revocation of this license, in addition to any other sanctions imposed by AGRSS. The interpretation and enforcement (or lack thereof) of these terms and conditions, and compliance therewith, shall be made by AGRSS in its sole discretion.

2. As set forth on the Attachment, the logo(s) are made available to AGRSS registered companies in good standing in camera-ready, printed form in color and/or black [modify accordingly for electronic media]. The logo(s) may not be revised or altered in any way, and must be displayed in the same form as produced by AGRSS. The logo(s) can be used in black and white or in two colors. The official color of the logo(s) is Pantone Matching System (PMS) 012 and K. They may also be used in CMYK builds of 100K (black) & 0C/3M/100Y/0K (yellow). The logo(s) must be printed in their official color or in black.

3. The logo(s) may be used in a professional manner on the user's business cards, stationery, literature, advertisements, storefront window, trucks, Web site, or in any other comparable manner to signify the user's membership in AGRSS. The logo may never be used independent of the term "CONTRIBUTER," as set forth on the Attachment. Notwithstanding the foregoing, the logo(s) may not be used in any manner that, in the sole discretion of AGRSS: discredits AGRSS or tarnishes its reputation and goodwill; is false or misleading; violates the rights of others; violates any law, regulation or other public policy; or mischaracterizes the relationship between AGRSS and the user, including but not limited to any use of the logo(s) that might be reasonably construed as an endorsement, approval, sponsorship, or certification by AGRSS of the user, the user's business or organization, or the user's products or services, or that might be reasonably construed as support or encouragement to purchase or utilize the user's products or services. 4. Use of the logo(s) shall create no rights for users in or to the logo(s) or their use beyond the terms and conditions of this limited and revocable license. The logo(s) shall remain at all times the sole and exclusive intellectual property of AGRSS. AGRSS shall have the right, from time to time, to request samples of use of the logo(s) from which it may determine compliance with these terms and conditions. Without further notice, AGRSS reserves the right to prohibit use of the logo(s) if it determines, in its sole discretion, that a user's logo usage, whether willful or negligent, is not in strict accordance with the terms and conditions of this license, otherwise could discredit AGRSS or tarnish its reputation and goodwill, or the user is not an AGRSS registered company in good standing.
